Federal Flowdown Terms and Conditions for Federal Contract Funded Purchases

If this Purchase Order involves funds from a Federal government contract—or funds from a subcontract at any tier relating to a Federal government contract—the following clauses from the Federal Acquisition Regulation (“FAR”) and the Defense Federal Acquisition Regulation Supplement (“DFARS”) are incorporated into the Order by reference where applicable and form a part of the terms and conditions of the order. Seller agrees to comply with these terms and flow down all applicable FAR and DFARS clauses to lower-tier subcontractors as applicable. These terms apply cumulatively by thresholds listed below. SIBCR manages both grants and contracts; *if sellers are unsure if an Order involves funds from a Federal government contract it is their responsibility to ask SIBCR.*
